NOW THIS MOU WITNESSED AND HEREBY AGREED BETWEEN THE PARTIES HERETO AS UNDER:

The role of each party, activities, responsibility and financial aspects are given below:

- 1. LLMT will include the following information in suitable promotional material mentioning that the course is being conducted in collaboration with SEF Institute
- 2. The activities and progress of the work will be reviewed periodically, on a monthly basis and as and when required by the Directors of SEF Institute and Trustee of LLMT for suitable actions.

PROGRAMS TO BE OFFERED AND EXECUTION OF SAME:

The SEF Institute and LLMT shall conduct educational courses in the trust premises.

Responsibility of LLMT at their own costs:-

- The LLMT shall make coordinated efforts to make the courses to be conducted by 1. the SEF Institute self-sustainable.
- The LLMT will make brochures, prospectus, flyers & Posters and advertisement ii. formats but the contents & designs for the same would be provided by SEF Institute to LLMT and will be pre approved by Travel and Tourism Program.
- SEF institute will be allowed to put their program flyers on the notice board as III. well as posters.
- After the tenure of this MOU, both the parties will have the right to review the iv. association and, if agreed, the same can be renewed on mutually agreed terms.

Responsibility of SEF Institute at their own costs:-

- Delivery of Program Travel and Tourism Program and short term certificate programs. i.
- Providing study material on line or off line ij.
- Detailed Workbooks with exam oriented questions for Travel and Tourism Program iii.
- Online Mock Exams log in ids and passwords /Practical Assignment work for Travel and iv. Tourism Program.
- Sufficient Training to counselors for converting enquiries to enroliments ٧.
- Coordination between Institute, students & SEF Institute for registration for Travel and vi. Tourism Program
- Conducting marketing seminars in order to create mass awareness as per the convenience viL of both the sides.

DURATION AND FINANCIAL AND OTHER TERMS:-

- 1. This Memorandum of Understanding will be valid for a period of 3 years from the date of commencement of the first batch
- 2. a. SEF Institute will conduct a seminar giving information regarding Travel and Tourism Program conducted by SEF Institute at LLMT premises.

b. SEF Institute will be allowed to have a kiosk at LLMT premises.

3. The accounts departments of both the parties will maintain their respective books of account.

"Fees shall be collected by LLMT. Fees collected will be shared between LLMT and SEF Institute in Proportion of 30% to LLMT and 70 % to SEF Institute"

- 4. Both the parties shall have the right to terminate this agreement by giving 2 months prior written notice to the other party. After receipt of or giving such notice of termination, LLMT shall stop enrolling new students. However, SEF Institute shall be allowed to and will be responsible to complete the courses which are going on during that period and the SEF Institute shall provide all cooperation and support to the LLMT in doing so.
 - The LUMT shall not use or claim any right on the curriculum used for the courses, its copyrights, other registered trademarks and intellectual property rights of SEF Institute.
 - 6. In future both parties mutually decide to offer other programs jointly to its students of self financing and B.com section.
 - The LLMT shall not sign up or work with any other Educational institute or any third party for a similar identical programme with that of the SEF Institute during the contract period and also on completion or termination of the contract for a minimum period of 3 years.
 - 8. On termination of this agreement, both the parties will stop scheduling any further programs at the campus of the LLMT and no students will be enrolled from that day for such programs/courses. However, it will be the joint responsibility of the LLMT and SEF Institute to ensure that the students enrolled by both parties prior to that date will receive the complete training program for which they are already enrolled. If any claims by students, vendors or any other party arise thereafter due to this project the same will be handled and settled by LLMT and SEF Institute Jointly.

Other Responsibilities:

- Certificates shall be issued by SEF Institute to successful students after completion of the program for DMM.
- II. In case of Short Term certificate program, certificates will be issued jointly by LLMT and SEF institute.
- III. LLMT and SEF Institute will upload information regarding all programs of each other on each other's website.

ARBITRATION

The parties hereto have agreed that in the event of there being any disputes and/or disagreements by and between the parties hereto in respect of interpretation of any of the terms and conditions herein contained as also in respect of any manner touching and/or arising out of these presents, the same shall be referred for arbitration as per the provisions of Arbitration and Conciliation Act, 1996 to a sole Arbitrator and the rules framed there under from time to time and the decision of the Arbitrator shall be final and binding upon the parties hereto.
