Solar PV Power Generation Plant

Lala Lajpatrai College is committed to minimize and sustainably manage its use of electricity. The College believes in reducing the consumption of electricity produced by non-renewable resources by switching to clean energy sources like solar energy for purposes like lighting the campus.

Keeping in mind the same commitment, in the academic year 2018-19 the Solar Power Panel (Captive Solar PV Power Generation Plant - Ongrid- 3KWP) was installed on the college rooftop on 10th October 2019. It harnesses abundant solar energy and generates self-sustainable green and clean energy using Solar PV power generation system.

This is to certify and declare that the On Grid Solar PV power generation system is installed and implemented at M/s. Lala Lajpatrai College by us in the month of December 2019. The system is 3 KWP which shall be connected to the common meter for net metering. The system has been checked post installation and working fine.

The system is designed, installed and implemented as per the guidelines from MNRE and government authorities. Here by we declare that that system is functioning as required and is ready to be handed over for inspection and further process to BEST power for connection of the net metering system.

The approximate saving using this system would be around 4,500 units per annum till now.

The use of solar system is equivalent to planting 148 teak wood trees and preventing about 92 tonnes of carbon emission per year.

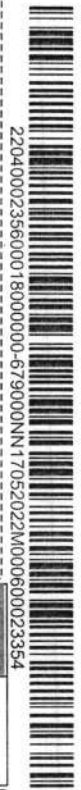

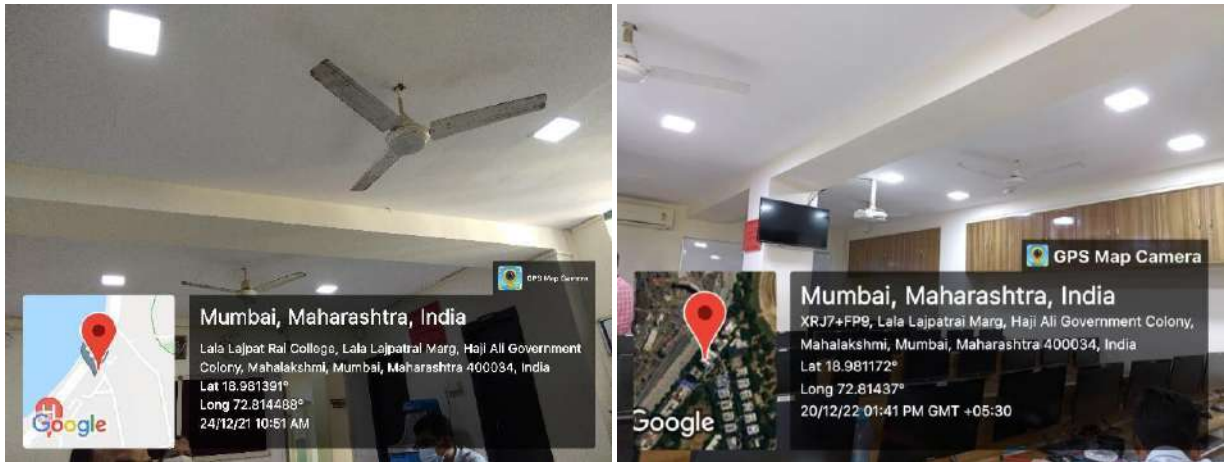

1. Three Bin System of Solid Waste Segregation:

LalaLajpatrai College follows a Three Bin System to segregate solid waste generated in the college.

Solid Waste generated from the college Premises is collected by Housekeeping Staff and the stored in the garbage yard, from where it is collected by Municipal Garbage Van every morning. The College follows Three Bin System for waste segregation:

- (a) Green for Degradable Waste,
- (b) Blue for Non-degradable Waste and
- (c) Black for Non-recyclable Waste.

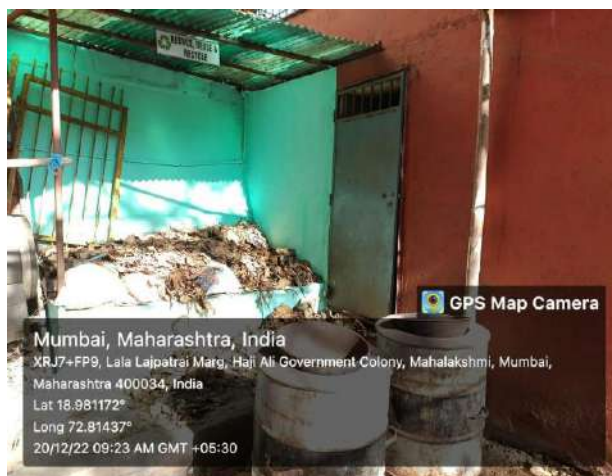
The garbage so segregated is collected by the Garbage Vans of Municipal Corporation for safe disposal.

2. Composting using Hand Tumbler and Ground Pit:

Waste generated from the canteen and garden is converted into manure using decompose process, in both hand tumblers and ground pit. The compost pit was installed in the college premises for composting the canteen (wet) waste in collaboration with **Stree Mukti Sangathana**, an NGO. 60 kg of fine quality compost (manure) was obtained in the first cycle. The manure was sold out to the Teachers and Non-Teaching staff, the money generated from the sale was used to celebrate Diwali with the inmates of St. George Infirmary. Also, the remaining manure is used in the college garden.

3. Recycling of Waste Paper:

The College emphasises 'Reduce, Reuse and Recycle' Policy for the management of waste. The paper waste from College Office, Examination Halls and Staff Rooms is collected for recycling.

The NGO collects paper waste from the College. 40% of the revenue generated from the same goes to the welfare of the female rag pickers, while the remaining 60% of the same is provided as recycled papers' stationary (writing pads) to the college.

1. Preference to PWDs in Admissions:

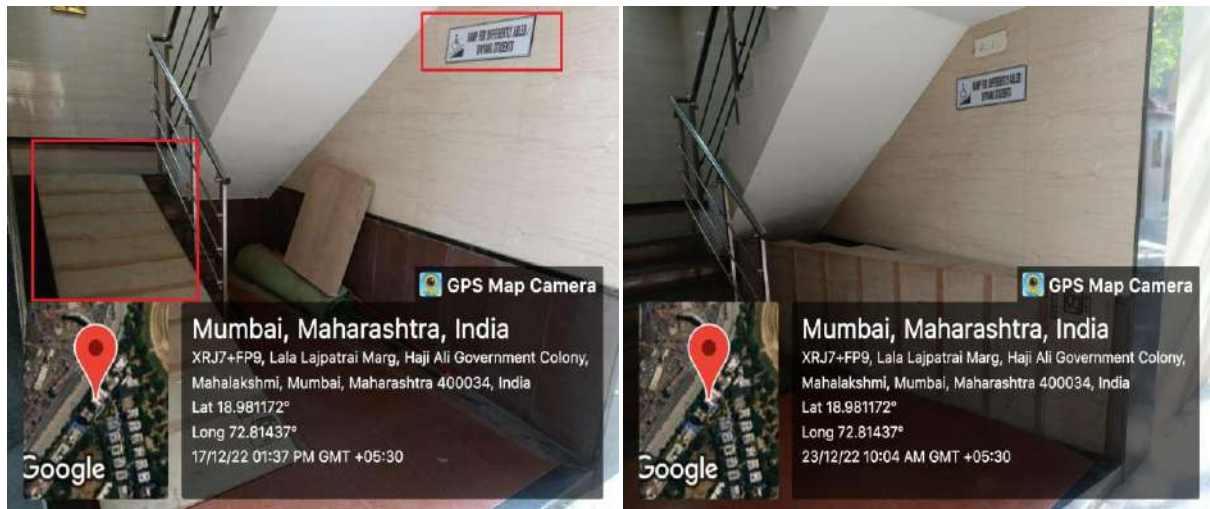

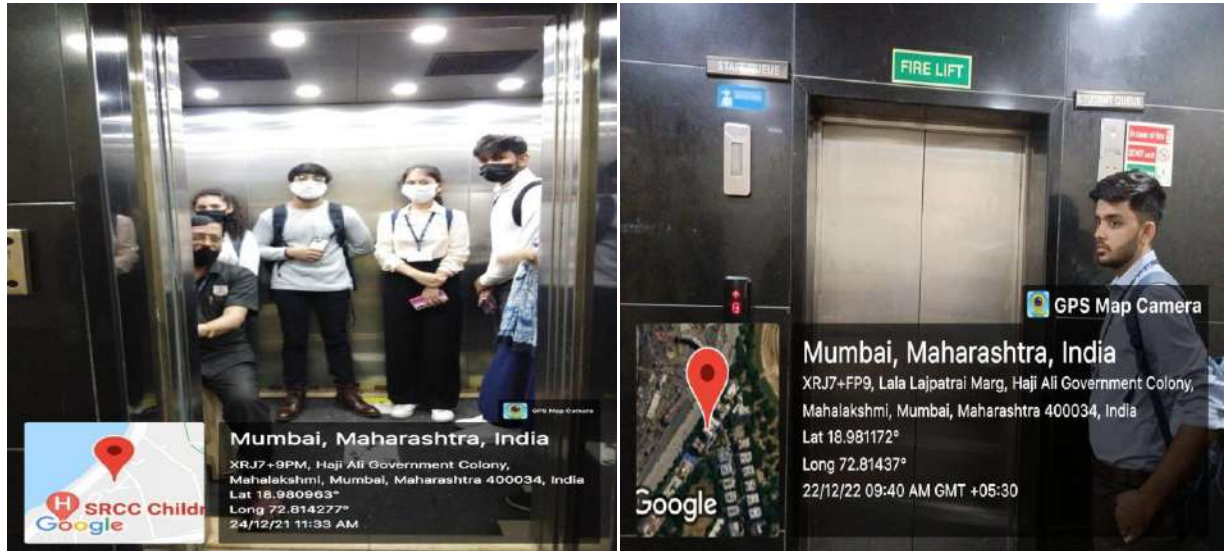
2. Ramp:
